Positioned within the tenth percentile of distributors in the industry, MQ Pharmaceuticals integrates its carbon reduction initiatives with its ESG goals, ensuring sustainable growth and operational excellence.

In its initial operational year (2025), MQ Pharmaceuticals projects the following carbon emissions:

### 2. Purpose

### 3. Scope

This plan applies to:

- Scope 1 (Direct Emissions): Emissions from Company-owned or controlled sources, such as on-site fuel combustion and Company-owned vehicles.
- Scope 2 (Indirect Emissions): Emissions from the generation of purchased electricity, heating, and cooling.
- Scope 3 (Value Chain Emissions): Emissions from activities outside direct control, including supply chain operations, business travel, and distribution logistics.

### 4. Key Principles

MQ Pharmaceuticals is committed to:

- Transparency: Measuring, reporting, and communicating carbon emissions and reduction efforts.
- Efficiency: Optimizing operations to minimize energy consumption and resource use.
- Innovation: Investing in low-carbon technologies and practices.

### 5. Carbon Reduction Framework

# 5.1. Measuring and Reporting Emissions

- Use the Greenhouse Gas (GHG) Protocol and comply with UK government reporting standards.
- Publish a detailed Carbon Report with metrics such as tCO2e (tonnes of CO2 equivalent) for transparency.
